2	<i>Editorial Office's Comments</i> Science Editor: 1 Scientific quality: The manuscript describes a minireviews of the association between celiac disease and vitiligo. The topic is within the scope of the WJG. (1) Classification: Grade A and Grade C; (2) Summary of the Peer-Review Report: The presentation of the results and the tables are fine, the discussion is very detailed. However, there are still some minor and important	[Y]

	issues, some professional terms need to be replaced, some content is not clear, etc. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables; (4) References: A total of 67 references are cited, including 13 references published in the last 3 years; and (5) Self-cited references: There is 1 self-cited reference. 2 Language evaluation: Classification: Grade A and Grade A. A language editing certificate issued by editage was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by the National Natural Science Foundation of China. The topic has not previously been published in the WJG. 5 Issues raised: (1) I found the title was more than 18 words. The title should be no more than 18 words; and (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s). 6 Recommendation: Conditionally accepted. Company Editor-in-Chief: I recommend the manuscript to be published in the World Journal of Clinical Cases.

For citations where no author is indicated, a superscript number should be placed at the end of the sentence. No superscript numbers are used when the reference number is described in the text; for example, "The experimental method used has been described in reference [8]."
