The questions raised by the reviewers should be answered; (3) Format: There are 5 tables and 2 figures; (4) References: A total of 34 references are cited, including 13 references published in the last 3 years; and (5) Self-cited references: There is no self-cited reference. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate and PRISMA 2009 Checklist. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WIP. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text. 6 Recommendation: Conditionally accepted. Company Editor-in-Chief: I have reviewed the Peer-Review
