No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by Indian Council of Medical Ressearch; Department of Biotechnology; ICMR-NIN-Intramural Grant. The topic has not previously been published in the WJH. 5 Issues raised: (1) The title is not allowed to have other abbreviations except COVID-19 and SARS-CoV-2. All acronyms shall be expressed in full and the title shall not exceed 18 words; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (3) Please write the "Conclusion" section at the end of the main text.
