	<p><b>Science Editor:</b> Recommend for rejection. Scientific classification: Grade D and Grade C. Language classification: Grade B and Grade B. Scientific classification does not meet the publication standard of WJGO. Reviewer pointed out that the article is nicely written, however, this article is in the form of letter to the editor, and the specific references, included data and figures can not be seen. The scientificity and reliability of data grouping cannot be evaluated. Therefore, I suggest reject this manuscript.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastrointestinal Oncology, and the manuscript is conditionally accepted.
