(3) Format: There is 1 figure; (4) References: A total of 178 references are cited, nearly 1/3 references published in the last 3 years; (5) Self-cited references: no 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJGO. 5 Issues raised: The "Author Contributions" section is missing. Please provide the author contributions. 6 Re-Review: No required 7 Recommendation: Conditional acceptance
