2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes an observational study of the effect of Oxaliplatin-induced neuropathy on the quality of life of patients with colon-rectal cancer. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: It is a well-written manuscript which studies a frequent consequence of adjuvant or palliative chemotherapy in colonic cancer. The relatively small size of the study population contrasts with the frequency of the pathology, a multicentric study would be more relevant. A single-center study on 111 patients does not allow us to assess the global incidence of neuropathy. this objective must be corrected; (3) Format: There are 4 tables and 1 figure; (4) References: A total of 32 references are cited, including 8 references published in the last 3 years; (5) Self-cited references: There are no self-citations; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJG. 5 Issues raised: (1) The title is too long, and it should be no more than 18 words; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The "Abstract" section is missing. Please add the abstract; (4) The "Key Words" section is missing. Please add the key words; (5) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (6) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (7) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Recommendation: Conditionally accepted.
