(3) Format: There are 4 tables and 4 figures; (4) References: A total of 13 references are cited, with only one reference published in the last 3 years; (5) Self-cited references: There are no self-cited references. (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially those published by the peer reviewer(s) him/herself (themselves).
