2	<i>Editorial Office's Comments</i> Science Editor: 1 Scientific quality: The manuscript assessed the effect of Calycosin on lung injury associated to severe acute pancreatitis, and showed that Calycosin reduces the serum amylase	[Y]

levels and alleviates histopathological injury. The topic is within the scope of the WJG. (1) Classification: Grade A, A, C, and D ; (2) Summary of the Peer-Review Report: local and systemic tissue damage due to acute pancreatitis remains a medical challenge, it is therefore important the identification of effective therapies. However there is no control drug to confirm the efficacy of Calycosin. There are too may Figures and several concerns raised to the reviewers that should be answered; (3) Format: There are 2 tables (plus one as supplementary file) and 11 figures; (4) References: A total of 39 references are cited, including 7 references published in the last 3 years; (5) Self-cited references: There are no self-cited references. (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially those published by the peer reviewer(s) him/herself (themselves).
