	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a minireview of the association between direct-acting antivirals and hepatocellular carcinoma occurrence and recurrence. The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This is a review article that summarizes the results of dozens of studies. Several studies are clearly presented in the table. It is the product of the efforts of the authors. However, even in the text, many research results are listed in no particular order, making it difficult to read. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables; (4) References: A total of 77 references are cited, including 25 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
