2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: This is a case report and literature review that highlighted a case of Hypereosinophilia with cerebral venous sinus thrombosis and intracerebral hemorrhage. The topic is within the scope of the WJG. (1) Classification: Grade C and Grade D; (2) Summary of the Peer-Review Report: Authors conclude that HE can cause CVST, and a high eosinophil count is an initial diagnostic clue of this condition. authors fail to provide direct evidence showing colitis and cerebral venous sinus were eosinophilic disorders in this case. The patient complained diarrhea at first, and colonoscopy was important to clarify the diagnosis. Besides, there were still many conditions related to hypereosinophilia, including inflammation bowel disease. Colonic biopsy was also needed to prove the diagnosis of eosinophilic colitis. According to the clinical course, we could only conclude HE with CVST and colitis. Thrombocytopenia could be caused by a lot of factors, such as HIT. (3) Format: There are 1 tables and 3 figures; (4) References: A total of 25 references are cited, including 4 references published in the last 3 years; (5) Self-cited references: There are no self-cited references.; (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially those published by the peer reviewer(s) him/herself (themselves). (3) History of present illness should be rewritten to be more clear and concise. (4) Further discussion is necessary regarding the place of this case in the literature, compared to others and what other diagnoses are possible in this regard. 6 Re-Review: Required 7 Recommendation: Rejection</p> <p>Company Editor-in-Chief: I agree with the Science Editor's suggestion of rejection.</p>
