Science Editor: 1 Scientific quality: The retrospective study describes " The Role of Multidetector Computed Tomography in Patients with Acute Infectious Colitis". The topic is within the scope of the WJG. (1) Classification: Grade B, Grade B, and Grade D; (2) Summary of the Peer-Review Report: (05842325): The paper seems to be helpful for a specific diagnosis of infectious colitis and worth publishing. However, several points should be clarified for acceptance. The authors indicated that several MDCT parameters were significantly associated with bacterial colitis. In general, discrimination between bacterial and viral colitis may be usually done by more simple ways, for example, white blood cell and neutrophil counts or CRP. They should show superiority of MDCT by such as ROC analyses. In addition, they did not show weight of each parameter of MDCT. They should indicate which parameters are most important for discrimination of etiology or make a formula for prediction of bacterial colitis. (05233850): The topic is interesting and could be useful in every day practice. As authors explain, the study has several limitations: this study was performed in a retrospective, observational, and single center manner, there was no control group of patients without colitis, and also, there were more patients in the bacterial colitis group (84%) compared to too few patients in the viral colitis group (16%). The present study only dealt with infectious colitis. Thus, a large prospective and well-designed study, including protocols-such as MDCT,

Though the inclusion of a higher number of cases, and more disease types (including IBD, microscopic colitides etc.) would help to significance of the study, the current results are also impressive and can be the preliminary basis for a further extended investigation. The study is well designed and well presented, the images are all help the understanding of the text. The discussion is clear and logical. The used reference list are all adequate. I suggest to accept the manuscript for publication. (3) Format: There are 6 tables and 6 figures; (4) References: A total of 29 references are cited, including 0 references published in the last 3 years; (5) Self-cited references: There are 0 self-cited references; (6) References recommendations: The authors should update proper references. 2.Language evaluation: Classification: Grade B, Grade B, Grade B. 3 Academic norms and rules: The authors provided the Non-Native Speakers of English Editing Certificate, Institutional Review Board Approval Form, Biostatistics Review Certificate, and, Signed Informed Consent Forms. 4 Supplementary comments: This is a retrospective study. The opic has not previously been published in the WJG. 5 Issues raised: (1)The "Author Contributions" section is missing. Please provide the author contributions. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance
