The topic is within the scope of the WJCC. (1) Classification: Grade C, Grade C and Grade C; (2) Summary of the Peer-Review Report: These 2 case reports have clearly shown satisfactory outcomes of Itraconazole treatment in infantile hemangioma. Please explain why itraconazole is better and safer than propranolol. If there are other</p>	[Y]

studies compare the comparison of propranolol and itraconazole, please add them in the discussion to increase clinician understanding of alternative therapies for IHs. The authors should explain the reason how oral itraconazole administration was given first in discussion; (3) Format: There are 2 figures; (4) References: A total of 25 references are cited, including 10 references published in the last 3 years; (5) Self-cited references: There are no self-citations; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. A language editing certificate issued by Medjaden was provided. 3 Academic norms and rules: The authors provided the signed informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been

published in the WJCC. 5 Issues raised: (1) The “Author Contributions” section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) The “Case Presentation” section was not written according to the Guidelines for Manuscript Preparation. Please re-write the “Case Presentation” section, and add the “FINAL DIAGNOSIS”, “TREATMENT”, and “OUTCOME AND FOLLOW-UP” sections to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Recommendation: Conditionally accepted.
