Science Editor: 1 Scientific quality: The manuscript describes a case control study of the developing a nomogram for predicting the depression of senior citizens living alone while focusing on perceived social support. The topic is within the scope of the WJP. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: In this study, the authors developed a nomogram for predicting the depression of senior citizens living alone while focusing on perceived social support. They concluded that the experiences of suicidal urge over the past year, dissatisfaction with help from neighbors, subjective loneliness, age, and low self-esteem were significant predictors of depression of the senior citizens living alone. The questions raised by the reviewers should be answered; (3) Format: There are 4 tables and 3 figures; (4) References: A total of 51 references are cited, including 13 references published in the last 3 years; (5) Self-cited references: There is 1 self-cited reference. The self-referencing rates should be less than 10%. Please keep the reasonable self-citations (i.e. those that are most closely related to the topic of the manuscript) and remove all other improper self-citations. If the authors fail to address the critical issue of self-citation, the editing process of this manuscript will be terminated; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
