The questions raised by the reviewers should be answered; (3) Format: There is no table or figure; (4) References: A total of 35 references are cited, including 7 references published in the last 3 years; (5) Self-cited references: There is no self-cited references. 2 Language evaluation: Classification: Grade B. The manuscript is reviewed by a native English editor. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the AIGE. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) PMID numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Recommendation: Conditional acceptance.
