The authors need to provide the table with the published cases or known reasons of HPVG or NEC, treatment, outcomes, risk factors (optional). The questions raised by the reviewers should be answered; (3) Format: There are 4 figures; (4) References: A total of 20 references are cited, including 7 references published in the last 3 years; (5) Self-cited references: There are no self-citations; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
