The manuscript investigates the association between age at diagnosis of type 2 diabetes and cardiovascular risk profile using a pooled analysis. b. The scientific quality classification of the manuscript provided within the peer-review report is Grade B (Very good). c. Peer reviewer raised the following queries- 'Was the labs obtained in the fasting state ? Since you have the 5 features of Metabolic Syndrome please report the frequency of MetS in the 3 groups by the Alberti et al global definition . Since you had Asians/Indians more commonly in the <40 group please cite the pioneering work of Jialal I et al eg Diabetes Research, 1986 since they showed that in young Indian T2D patients in South Africa they had worse cardiovascular outcomes and were predominantly female like in your study.' The questions raised by the reviewers should be answered; d. The manuscript has 1 figure and 4 tables. e. A total of 23 references are cited, including 11 citations published within the last 3 years. f. There are 8 self-citations. The self-referencing rate should be less than 10%. Presently its >30%. g. The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially those published by the peer reviewer(s) him/herself (themselves).
