Science Editor: 1 Scientific quality: The manuscript is a meta-analysis of the efficacy of Chinese herbal medicine for functional constipation. The manuscript type designated by the author is consistent with the content of the manuscript. The topic is within the scope of the WJCC. (1) Classification: Grade B (2). (2) Summary of the Peer-Review Report: The meta-analysis is well done and evaluates several outcomes of the treatment, with interesting findings and low heterogeneity, that allow extrapolation to clinical settings. There is no subgroup analysis by specific ingredients, which is a major limitation. (3) Format: There are 6 figures and 2 tables in the manuscript, and all of them are of adequate quality. (4) References: Citation of references in the manuscript is sufficient and reasonable. A total of 115 references are cited, of which 34 references were published in the last 3 years. (5) Self-cited references: There are two self-cited references in the manuscript (111 and 114). (6) References recommendations: The reviewers made no references recommendations. 2 Language evaluation: Classification: Grade A (1) and Grade C (1). The authors have not provided a language editing certificate. 3 Academic norms and rules: The authors have not provided a Biostatistics Review Certificate. While the authors have denied any conflicts of interest in the manuscript, a signed Conflict-of-Interest Disclosure Form was not provided. A PRISMA Checklist was sent by the authors. No academic misconduct was found by the Google/Bing search. 4 Supplementary comments: This is an unsolicited manuscript.
