(1) Classification: Grade B (2) Summary of the Peer-Review Report: The study aimed to evaluate the relation between vWF and liver cirrhosis, its relation to other prognostic indicators, and the prognostic value of vWF for mortality. The study confirmed a significant relation between vWF and liver cirrhosis, CRP, ferritin and D-dimer concentration, and also confirmed that in patients with liver cirrhosis vWF, MELD score and CRP were significantly related to death and significant predictors of mortality. This is an interest study to show the impact of vWF in liver cirrhosis. I would recommend the authors to revise the manuscript according to reviewer's comment. (3) Format: There are 3 tables and 3 figures; (4) References: A total of 37 references are cited.
