The questions raised by the reviewers should be answered; (3) Format: There is 1 figure; (4) References: A total of 37 references are cited, including 19 references published in the last 3 years; (5) Self-cited references: There is no self-cited references. 2 Language evaluation: Classification: Grade A and B. The authors are native English speakers. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the AIGE. (13)5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) For PMID and DOI numbers of references from English-language journals, please ensure the PMID and DOI numbers in the square brackets, and PMID should be ahead of DOI numbers; (4) In the main text, the reference number should be indicated with square brackets in the upper right corner of the place where it is cited. 6 Recommendation: Conditional acceptance.
