Science Editor: 1 Scientific quality: The manuscript describes a retrospective study of the influence of overweight and obesity on the mortality of hospitalized patients with community-acquired pneumonia. The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This manuscript is meaningful. The acronyms in the abstract, the sample size of the method and guidelines for assessing mortality data collection, and the tables in the results need to be revised. The questions raised by the reviewers should be answered; (3) Format: There are 3 tables; (4) References: A total of 62 references are cited, including 13 references published in the last 3 years; and (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com.
