anesthesia in cardiac surgery. This study is overall well designed and the results are very interesting. Data in tables are good, and the figures are informative. The questions raised by the reviewers should be answered; (3) Format: There are 1 table and 4 figures; (4) References: A total of 27 references are cited, including 13 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. The Editorial Office will close and remove the peer reviewer from the F6Publishing system immediately. 2 Language evaluation: Classification: Grade B.
