Aim and content are within the scope of the journal. (1) Classification: Grade B, grade B and grade C (2) Summary of the Peer – Review Report: Results were already published in another recent study by authors, only new results should be presented, some results are similar to previous study. Figure 1 should be corrected and figure 4-D doesn't show results properly, should be corrected. Discussion should be extended and limitatins of the study should be pointed out. Results should be restated in the discussion. This was stressed by two reviewers. (3) Format: There are 4 figures. Corrections are needed. (4) References: A total of 37 references are cited, including 15 published in the last 3 years. Some references are not correctly written (p.e. ref no.28) (5) Self-cited references: There are 3 self-cited references, which is less than 10%. (6) Reference recommendations: There are no improper references recommendationes. 2 Language evaluation: Grade A, grade B and grade B. A language verification by English language editing company was provided. 3 Academic norms and rules: The authors provided the Biostatistics statement and Conflict of interest disclosure form. No academic misconduct was found by the Google search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support</p>	[Y]
