The topic is within the scope of the WJO. (1) Classification: Two Grades B; (2) Summary of the Peer-Review Report: The problems presented in this paper are quite common and the solution of this issue is novel.</p>	[Y]

The introduction is well written and clear. The questions raised by the reviewers should be answered; (3) Format: There are 2 tables and 4 figures; (4) References: A total of 24 references are cited, including 1 reference published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves). If the authors find the peer reviewer(s) request for the authors to cite improper references published by him/herself (themselves), please send the peer reviewer's ID number to editorialoffice@wjgnet.com. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all

Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please add the “Article Highlights” section at the end of the main text. 6</p> <p>Re-Review: Not required. 7 Recommendation: Conditional acceptance.</p> <p>Company Editor-in-Chief: I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Orthopedics, and the manuscript is conditionally accepted.
