The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The study is interesting, and well designed. The inclusion and exclusion criteria are reasonable.</p>	[Y]

The questions raised by the reviewers should be answered; (3) Format: There are 3 tables and 4 figures; (4) References: A total of 18 references are cited, including 6 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
