Abstract	3a	Background: What does this case report add to the medical literature?	<u>Yes</u>
	3b	Case summary: chief complaint, diagnoses, interventions, and outcomes	<u>Yes</u>
	3c	Conclusion: What is the main "take-away" lesson from this case?	<u>Yes</u>
Introduction	4	The current standard of care and contributions of this case—with references (1-2 paragraphs)	<u>Yes</u>
Timeline	5	Information from this case report organized into a timeline (table or figure)	<u>Yes</u>
Patient Information	6a	De-identified demographic and other patient or client specific information	<u>Yes</u>
	6b	Chief complaint—what prompted this visit?	<u>Yes</u>
	6c	Relevant history including past interventions and outcomes	<u>Yes</u>
Physical Exam	7	Relevant physical examination findings	<u>Yes</u>
Diagnostic Assessment	8a	Evaluations such as surveys, laboratory testing, imaging, etc.	<u>Yes</u>
