Overall, the letter mainly summarizes the context of the review and brings some studies that show the unbeneficial effect of gut microbiota-derived metabolites. The questions raised by the reviewers should be answered; (3) Format: There are no tables and no figures; (4) References: A total of 11 references are cited, including 4 references published in the last 3 years; (5) Self-cited references: There is no self-cited reference; and (6) References recommendations: The authors have the right to refuse to cite improper references recommended by the peer reviewer(s), especially references published by the peer reviewer(s) him/herself (themselves).
