| Introduction | 4 | The current standard of care and contributions of this case—with references (1-2 paragraphs) | <u>Page 4</u> |
| Timeline | 5 | Information from this case report organized into a timeline (table or figure) | <u>Page 14</u> |
| Patient Information | 6a | De-identified demographic and other patient or client specific information | <u>Page 4</u> |
| | 6b | Chief complaint—what prompted this visit? | <u>Page 4</u> |
| | 6c | Relevant history including past interventions and outcomes | <u>Page 4</u> |
| Physical Exam | 7 | Relevant physical examination findings | <u>Page 4</u> |
| Diagnostic Assessment | 8a | Evaluations such as surveys, laboratory testing, imaging, etc. | <u>Page 4,5</u> |
| | 8b | Diagnostic reasoning including other diagnoses considered and challenges | <u>Page 5</u> |
| | 8c | Consider tables or figures linking assessment, diagnoses and interventions | <u>Page 6,14..</u> |
| | 8d | Prognostic characteristics where applicable | <u>..Page.5</u> |
| Interventions | 9a | Types such as life-style recommendations, treatments, medications, surgery | <u>Page 5,6</u> |
| | 9b | Intervention administration such as dosage, frequency and duration | <u>Page 5,6</u> |
| | 9c | Note changes in intervention with explanation | <u>Page 5,6</u> |
| | 9d | Other concurrent interventions | <u>Page 6,7</u> |
| Follow-up and Outcomes | 10a | Clinician assessment (and patient or client assessed outcomes when appropriate) | <u>Page 7</u> |

| Informed Consent | 13 | Informed consent from the person who is the subject of this case report is required by most journals | <u>Page 12</u> |
| Additional Information | 14 | Acknowledgement section; Competing Interests; IRB approval when required | <u>Page 12</u> |
