Comment: The title of the article does not really reflect the content. In fact, the title is Liver Transplantation for Autoimmune Hepatitis however, the content is about recurrent AIH and de-novo AIH post-liver transplant. This article did not add any important information to the similar available works in the literature about this topic. This article needs to be written in an organized systematic pattern of sections and sub-sections to make it easy and understandable for the readers. In many parts of the article, the authors should pay attention to the English language and grammar mistakes that need revision and adjustment. Most of the references that were used are relatively old more than 5 years, though that several similar recent articles are available in the international literature.
