However, some revisions are still needed before being published in World Journal of Clinical Infectious Diseases. 1. Please refer to recent papers published in World Journal of Clinical Infectious Diseases and correct the format, such as: In title, all words should be bold and all words except for the first letter should be in lower case. In page 3, “Key words” and “Author’s contribution” should be changed to “Key Words” and “Author contributions”. In page 4, “To the Editor:” should be changed to “TO THE EDITOR:”. In page 4, “1” should be displayed in superscript “[1]”. Other citations should be modified accordingly. In page 8, “References:” should be changed to “REFERENCES”. 2. Abstract and Core Tip should be provided in the text according to the journal’s requirements. 3. As of 27 July, 2021, the global cumulative number of COVID-19 cases reported has been over 190 million according to the weekly epidemiological update on COVID-19 by WHO (Available from: <https://www.who.int/publications/m/item/weekly-epidemiological-update-on-covid-19---27-july-2021>). Should “COVID-19 cases crossed 30 million” be changed to “COVID-19 cases crossed 190 million” in page 6? 4. In all references, the first author should be bold. In reference 1, 2, 4 and 5, title should be added. In reference 3, “Lancet Public Health. 2020 May;5(5):e257. [https://doi.org/10.1016/S2468-2667\(20\)30076-1](https://doi.org/10.1016/S2468-2667(20)30076-1)” should be changed to “Lancet Public Health 2020; 5: e257 [PMID: 32224295 DOI: 10.1016/S2468-2667(20)30076-1]”. Please refer to recent papers published in World Journal of Clinical Infectious Diseases and correct the format. In page 1, Swarnakar P et al. should be added before the running title " COVID, stigma, disability and public health". In page 1, authors and their institutions should be used in correct uppercase or lowercase. In page 3, "[6]" and "[7]" should be changed to "[6, 7]". In page 4, "In summary," should be changed to "SUMMARY". 2. In page 4, "during COVID-19 pandemic" should be changed to "during the COVID-19 pandemic". Additionally, it's suggested that ACKNOWLEDGEMENTS section could be deleted if there is no acknowledgement. 3. In reference 1, 2, 6 and 7, "World Health Organization" or "The United Nations International Children's Fund (UNICEF)" should be bold, and cited date should be provided. Other suggestions have been listed in the uploaded revised version.
