	6c	Relevant history including past interventions and outcomes	<u>23-24/6</u>
Physical Exam	7	Relevant physical examination findings	<u>1-6/7</u>
Diagnostic Assessment	8a	Evaluations such as surveys, laboratory testing, imaging, etc.	<u>7-17/7</u>
