Dear Editor:

I wish to submit a Case Report for publication in the *World Journal of Clinical Cases*, titled "**Spontaneous liver rupture following SARS-CoV-2 infection in late pregnancy:** A case report and review of the literature." The paper was coauthored by Ambrož Radek, Stašek Martin, Molnár Ján, Špička Petr, Klos Dušan, Hambálek Josef, Skanderová Daniela.

This manuscript describes a crucial case of a 32-year-old woman who had completed 32 weeks of gestation and presented with epigastric pain and elevated liver enzymes. She had no previous long-term medication use or chronic diseases; however, her hospitalization course was quite eventful that included a positive reverse-transcriptase polymerase chain reaction results for the SARS-CoV-2 virus and an emergency cesarean section performed followed by the delivery of a stillbirth baby. The case was thoroughly investigated and clinical implications for future cases were described. We believe that such critical cases should be reported in the literature because until now, no cases of spontaneous liver rupture in pregnancy with coronavirus disease-19 have yet been reported.

Further, we believe that this paper will be of interest to the readership of your journal because this report describes the management of a severely critical obstetric and hepatological case scenario, which required various vital procedures to stabilize the clinical condition of the mother after fetal loss.

After careful review by your reviewers, we have made extensive changes. We believe that we have fully met your requirements for publication in your magazine.

Changes:

- 1) Improving the introduction: "Coronavirus disease-2019 (COVID-19) caused by severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) is characterized by systemic inflammatory response syndrome and vasculopathy."
- 2) Unification of terms: (COVID-19, etc.)
- 3) Abstract changes: "A 32-year-old pregnant patient (gestational age: 32 wk + four days) without any remarkable medical history or long-term medication presented with epigastralgia.", etc.

Introduction changes: "Moreover, acute liver injury has a higher mortality rate. Studies related to liver disease and involvement during pregnancy seem to be limited.", etc.

- 4) Changes in case presentation: form of sentences, exclusion of weight and height etc.
- 5) Changes in final diagnosis: form of sentences
- 6) Discussion: better explanation of placental damage
- 7) Correction of all references
- 8) Modification and unification of abbreviations
- 9) Addition of a mechanism of liver damage caused by SARS-CoV-2
- 10) Significant improvement in the linguistic quality of the text
