The article content contributes to the development of knowledge about the RSD but i have some recommendations about the Reference list: You have to change reference 18 in part in Discussion about "Current clinical guidelines" ...fixed combination therapy is a first choice in modern hypertension th. (according ESH 2018) You added too old references in this article (ref. 12 and ref. 18), please change them to novel JNC 9 Hypertension guidelines 2021 and ESH 2018 Hypertension guidelines or WHO 2021 hypertension guidelines. Additionally, you have to put all the remaining references in the same order (see ref. 8,9, 11, 13,14,15...).

**Authors:** Thank you for this great insight on our manuscript. We agree that this is the work on RSD aids in building a greater clinical understanding of this interventional procedure. Regarding your suggestions, our team truly appreciates them. We have updated our citations to NOT use the old JNC 6 guidelines but rather replaced them with the 2018 ESH hypertension guidelines and the WHO 2021 guidelines. This led to use replaces the stages of hypertensions with grades of hypertension as seen in 2018 ESH. In addition, we believe this revision allows for a better understanding of how the grades of hypertension correlate to medication regimens and morbidity risks found in additional literature worldwide. Secondly, we have placed all references in numerically order as seen in the flow of the manuscript and evaluated grammar with a native English speaker.
