This letter to the editor mainly discussed the pathophysiologic mechanisms and their association between COVID-19 and heart failure, which can help us in getting a better understanding of their interaction, therefore, may result in optimal management in those patients. However, below revisions are still needed before being published in World Journal of Virology. 1. It is suggested that the authors should give more specific advice on how to manage these COVID-19 patients with pre-existing or induced new-onset heart failure in the last paragraph of this manuscript. 2. Please refer to recent papers published in World Journal of Virology and correct the format. In page 1, the first author's affiliated institutions should be described firstly, not the second author's. In Author contributions section, "Siasos G, Oikonomou E, Vavuranakis M, and Tousoulis D gave final approval...", not all authors? It is suggested that these four authors' contributions should be stated clearly. In page 3, "LETTER TO THE EDITOR" should be changed to "TO THE EDITOR" according to the journal's requirements. references, all journal names should be italic, volume number should be bold, issues should be deleted, and "doi" should be changed to "DOI". In reference 2, "JAMA. 2020 Apr 28;323(16)" should be changed to "JAMA 2020; 323". Please check other references including content and format carefully according to the journal's requirements. Other suggestiones have been listed in the uploaded revised version.

The manuscript of Tsigkou et al. seems to have more of the characteristics of a mini review than that of a letter to the editor finalized to comment the article of John et al (ref. 1). This is also suggested by the high number of references reported (a total of 24 references). Finally, the comments to the article of John et al. are limited to the 4 initial lines of page 5. On the other hand, most of the "letter" deeply analyzes cardiological aspects which are related or not related to COVID-19.
