2. Some references are too old (before 2000) and need to be updated

RESPONSE: Thank you for your Suggestion.

We have removed some old references as per the suggestions. But, a few references such as reference numbers: 53, 54, 60, and 62 are retained as they denote the significance of the concept from the earlier period itself. Instead, we have cited recent cross-references (reference numbers: 55, 61, 63) and all of these are highlighted in dark grey colour.

Specific Comments to Authors:

In this review, the author described the role of TGF- β 1 in hepatocellular carcinoma.

There are several comments:

1. The preparation of this review is not good enough, for example, lots of small errors in the review, and poor tables and figures.
