Physical Exam	7	Relevant physical examination findings	<u>Page 4</u>

	8b	Diagnostic reasoning including other diagnoses considered and challenges	<u>Page 5</u>
	8c	Consider tables or figures linking assessment, diagnoses and interventions	<u>Pages: 8, 9</u>

Interventions	9a	Types such as life-style recommendations, treatments, medications, surgery	<u>Page 5</u>
