Please revise this part carefully and delete irrelevant content. 2) Please include the answer to (comment 6) in the diagnostic criteria of the TEM section of the main text. 3) Please include the figure used to answer (comment 11) of the previous round along with its explanation in the main manuscript. Reviewer #2: Scientific Quality: Grade C (Good) Language Quality: Grade A (Priority publishing) Conclusion: Minor revision Specific Comments to Authors: Please provide the HE-stained figure under low power to

prove that the tissue came from the fallopian tube. The current figure can not represent the whole field of it. And please provide the figure of IHC.
