"Opinion on double strategy to fight COVID-19: vaccination and at home early treatment with non-steroidal anti-inflammatory drugs "to be evaluated for publication in the World Journal of Meta-Analysis. The article was written by me and Dr. Flora Affuso, who, both, have great experience in the at home early treatment of COVID-19. We believe that COVID-19 should be fought with all possible weapons and not only with vaccination. In the past, when some observational studies were published showing similar results on the effects of a drug, promptly we proceeded to carry out a prospective randomized controlled study to ascertain the results. This was not done for NSAIDs, used with very good results, as shown by observational studies, for the early at-home treatment of COVID-19. We, already at the beginning of 2020, published an opinion article in the Journal, in which, among other things, indicated indomethacin as a potential drug for the treatment of the disease. We have revised the manuscript according to Your and Reviewers' suggestions. Unfortunately, one of the Reviewers did not understand well the aim of the manuscript asserting that they have carried out many RCTs on this topic. However, RCTs have been performed mostly in hospitalized patients and not with NSAIDs, while no RCTs have been performed to verify the efficacy of NSAIDs and, in particular, indomethacin, as early at home treatment of COVID-19. We believe that the manuscript was improved by revision and hope that it can be considered for publication in the Journal.
