<b>Patient Information</b>	<b>6a</b>	De-identified demographic and other patient or client specific information	<u>11/5</u>
	<b>6b</b>	Chief complaint—what prompted this visit?	<u>7/6</u>
	<b>6c</b>	Relevant history including past interventions and outcomes	<u>11/6</u>
<b>Physical Exam</b>	<b>7</b>	Relevant physical examination findings	<u>25/6</u>
<b>Diagnostic Assessment</b>	<b>8a</b>	Evaluations such as surveys, laboratory testing, imaging, etc.	<u>1/7</u>
