The 2023 Edition of Journal Citation Reports® cites the 2022 impact factor (IF) for WJH as 2.4; IF without journal self cites: 2.3; 5-year IF: 3.0; Journal Citation Indicator: 0.47. The WJH's CiteScore for 2022 is 3.6 and Scopus CiteScore rank 2022: Hepatology is 42/70. Before final acceptance, when revising the manuscript, the author must supplement and improve the highlights of the latest cutting-edge research results, thereby further improving the content of the manuscript. To this end, authors are advised to apply a new tool, the Reference Citation Analysis (RCA). RCA is an artificial intelligence technology-based open multidisciplinary citation analysis database. In it, upon obtaining search results from the keywords entered by the author, "Impact Index Per Article" under "Ranked by" should be selected to find the latest highlight articles, which can then be used to further improve an article under preparation/peer-review/revision.
