The authors prove a high frequency of diagnostic coincidence (95.3%) of the results of ultrasonographic examination with contrast and upper endoscopy in the diagnosis of peptic ulcer disease in children. Ultrasound of the gastrointestinal tract with contrast enhancement has a high clinical value in the diagnosis of peptic ulcer disease in children as a preliminary screening method and a good addition to gastroscopy.
