(3) Please add scale bar for figure 1 if possible. (4) Please provide the figures 4 and 5 with higher resolution. (5) Authors are required to provide standard three-line tables, that is, only the top line, bottom line, and column line are displayed, while other table lines are hidden. The contents of each cell in the table should conform to the editing specifications, and the lines of each row or column of the table should be aligned.
