	BCLC 0 and A stages? (2) Main manuscript content: The author	
	clearly stated the purpose of the study and the research structure is	
	complete. However, the manuscript is still required a further	
	revision according to the detailed comments listed below. (3)	
	Table(s) and figure(s): There are 4 Figures and 3 Tables should be	
	improved. Detailed suggestions for each are listed in the specific
