Specific Comments to Authors: An Excellent review that covers well a complex role and relationship of exosomes and NLRP3 in the pathogenesis of IBD with a view to identifying novel therapeutic avenues. Li et al. importantly highlight the role of further assessing the potential cross talk to identify novel therapeutic targets for UC. This article neatly sets up future potential scientific avenues that must be pursued to improve understanding of disease pathogenesis and improve the current spectrum of IBD therapeutics.

Therefore, to systematically sort out the current evidence in this area, we conducted the present review. Notably, although we did not address the current issues of UC in this review, we identified the current complexity of this field and suggested future research directions, which may be informative for researchers working in this field.
