All submitted figures, including the text contained within the figures, must be editable. Please provide the text in your figure(s) in text boxes. 3. Your manuscript has been checked by CrossCheck. Please read the attached CrossCheck report for details. Our editorial policy states the overall similarity should be less than 30%, the overlapped section should be less than 5% in single papers, including author's own work.
