Reviewer #1:

1. This article mainly aims to develop a diagnosis and treatment plan for hilar cholangiocarcinoma in your own country, but the arguments in the article mainly rely on foreign literature and lack epidemiological data from our own country. If there is domestic epidemiological data, it would be more relevant:

REPLY: Unfortunately, there is lack of local epidemiological data. Only a few short case series and a retrospective outcomes data is available, all available local data is referenced in the manuscript. Reference number: 9-12.

2. This article provides a detailed introduction to the diagnosis and surgical treatment of hilar cholangiocarcinoma, but there is relatively little introduction to palliative treatment. Currently, targeted immunotherapy for cholangiocarcinoma is flourishing, and I think a more detailed introduction can be provided:

Reply: We have expanded on the role of palliative chemotherapy in the palliative care section. We also expanded on results of KEYNOTE-966 trial to highlight advantage of immunotherapy
