This study addresses a subject which is greatly needed for not only better understanding mechanisms of the gut microbiome but providing foundational evidence that can be used for future research. While the study is small, this information is helpful to know. At the beginning of the AE portion of the Results section, could the authors please explain what the number 22 is in reference to? In the methods, it was noted that there were 22 stool samples. (2) Main manuscript content: The author clearly stated the purpose of the study and the research structure is complete. However, the manuscript is still required a further revision according to the detailed comments listed below. (3) Table(s) and figure(s): There are 3 Figures and 2 Tables should be improved.</p>	[Y]

Detailed suggestions for each are listed in the specific comments section. (4) References: A total of 43 references are cited, including 12 published in the last 3 years. The reviewer didn't request the authors to cite improper references published by him/herself. 3 Language evaluation: The English-language grammatical presentation needs to be improved to a certain extent. There are many errors in grammar and format, throughout the entire manuscript.
