2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the locally advanced lymphoepithelioma-like carcinoma at upper urinary tract. The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: The authors reported the rare case of urinary tract</p>	[Y]

lymphoepithelioma-like carcinoma, mixed type. With its rarity, there is no consensus on standard surgical procedures and adjuvant treatment. However, there are some issues should be addressed. The authors need to add more details in the “case presentation” section. The manuscript was systematically well written, with some language issues needed correction. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 5 figures. A total of 11 references are cited, including 3 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Enago was provided. 3 Academic norms and rules: The authors provided the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent, and the CARE checklist form. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study is without financial support. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
