2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the <i>Stenotrophomonas maltophilia</i>. The topic is within the scope of the WJCID. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors reported a good report. However, it is not extremely novel, and some references should be added. The questions raised by the reviewer should be answered; and (3) Format: There is 1 table. A total of 35 references are cited, including 2 references published in the last 3 years. There are no self-citations.</p>	[Y]

2 Language evaluation: Classification: Grade C. 3 Academic norms and rules: The authors provided the written informed consent. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 6% in the CrossCheck report. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCID. 5 Issues raised: (1) The language classification is Grade C. Please visit the following website for the professional English language editing companies we recommend: <https://www.wjgnet.com/bpg/gerinfo/240>; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) Please add some figures; (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation. Please re-write the "Case Presentation" section, and add the "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" sections to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
