The author proposes several revisions to the titles of chosen articles and has shared these insights with the editorial team overseeing their publication. (4) References: A total of 64 references were cited, all of which were published in the past 3 years. The reviewer didn't request the authors to cite improper references published by him/herself. 3 Recommendation: Conditional acceptance.
