with fecal calprotectin in acute infectious diarrhea in patients from South Korea. It is a well-designed study with good statistical analysis. The authors address the study limitations. Reviewer# 02840182 summarized the authors have compared efficacy of stool multiplex PCR assay in adult patients with acute infectious diarrhea with stool culture and inflammation markers in their retrospective study. Although the information in this article is not new, may contribute to the literature. The manuscript is well written. This study is important for demonstration of adult results. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 3 figures. A total of 30 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the Institutional Review Board Approval Form, and informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The study was supported by the Kangdong Sacred Heart Hospital Fund. The topic has not previously been published in the WJG. The corresponding author has not published articles in the WJG. 5 Issues raised: (1) I found there is no "Author contribution" section. Please provide the author contributions; (2) I
